It's safe to say we are *back in the swing of things* after a second successful conference in 2021! This past year, we moved our Fall Conference from Peoria to Bloomington-Normal and we had an excellent turnout. We were joined by 50 vendors and over 300 attendees! We are so thankful to our vendors. They work hard to bring necessary services to your counties and constituents, so we are always thankful to get face time with them at the conferences. Some of the highlights of this conference included: a sold out exhibit hall, plenty of ARPA education, an evening show with Abraham Lincoln and Ulysses S. Grant that was graciously provided by Bellwether, and a full day of training and CE put on by each affiliate group. We rounded out the conference with our Presidents' Banquet and non-stop laughter thanks to GIT Improv.

Wednesday, we started our day with a full house in the IMRF session. We are so glad that Randy Stevens was able to join us again after taking a break from conferences since the beginning of the COVID-19 Pandemic. The Illinois Municipal Retirement Fund is important to every one of our attendees and we always walk away feeling more informed than when we entered.

Immediately following the IMRF session, we were joined remotely once again by Emily Swenson Brock, director of the Government Finance Officers Association, to ask more questions and get into the nitty gritty of what the American Rescue Plan Act (ARPA) looks like now as it is being used. She provided us with a copy of her informational powerpoint and it will be available on our website soon, along with presentations from the other ARPA presenters. So, if you weren't able to attend the conference or missed out on some details, you can find those there by the end of the month!

Following Emily's presentation, we heard from Bruce DeLashmit, the founder of Bellwether, LLC. Bruce's experience includes over 35 years of extensive transformation leadership and consulting in small and large companies as well as national and local government structures. Bellwether has been helping many counties with the ARPA reporting requirements and he provided some valuable insight on that. His presentation will also be available online.

After lunch, we had an informative session with Donna Rogers (MEd, SPHR, SHRM-SCP) on Resume and Application Review. She helped us with something that everyone needs to revisit from time to time: how to select the best applicants to bring in for an interview. Donna gave her

recommendations on not judging a book by its cover and having a process in place for applicant selection.

Then, it was back to ARPA and we got to hear a presentation on how local governments are planning to use their ARPA fiscal recovery funds by Laura Goddeeris, AICP. Laura is Director of Survey Research for the International City/County Management Association and she oversees quantitative and qualitative research activities on enduring and emerging local government management issues and manages relationships with external researchers, partners, and funders.

Our final education session of the day was a panel of experienced County representatives from around the state who facilitated a discussion on how our counties can use these once-in-a-generation federal funds. The panel was made up of the following members: **Darlene Kloeppel**, Champaign County Executive; **Jim Marlo**, Williamson County Commissioner and Chair; **John McIntyre**, McLean County Board Chair; **Sharon Schallhorn**, Bureau County Administrator; **Scott Schwerer**, McDonough County Board Chair; and **Michael Skala**, McHenry County Finance Chair. Wednesday night was a time to kick back and relax. Thanks to Bellwether, LLC, we were treated to a show called *"Timeless Wisdom: An Evening with American Icons."* Those in attendance got to hear from historical impersonators of two men who cared deeply about our country: Abraham Lincoln and Ulysses S. Grant. Everyone agreed that the show was excellent.

On Thursday, attendees broke into their affiliate groups for more training and education alongside their colleagues. We ended the day with the President's Banquet where we awarded the title of 2021 County Official of the Year to Bob Kahman, McLean County Assessor. We also held a ceremony to induct new members of the Board and Executive Board into office. At the end of the night, we were treated to a hilarious show by GIT Improv. We certainly all needed to laugh considering the chaotic times we are currently living in, and they more than delivered! The conference wrapped up Friday morning with a short breakfast where affiliates gave reports about their affiliate training. It is our hope that everyone headed home thankful to gather together.

2021 County Official of the Year



Robert T. "Bob" Kahman McLean County Supervisor of Assessments

Each year the IACO recognizes an outstanding county government official who best demonstrates our mission of improving the quality of county government through education, promoting responsible public policy, and providing ethical service while maintaining a high standard of performance. The County Official of the Year Award recognizes a county government official or employee who has demonstrated a commitment to excellence in county government both within his or her own community and on a regional or statewide level. The 2021 County Official of the Year was awarded to Robert T. "Bob" Kahman. He was nominated for the award by eight colleagues from throughout the state.

"Bob has been a leader that knows so many things and does so much well. Yet, he is always willing to help mentor others by sharing what he knows, not only as county assessor but life also," said Larry Wilson, Rock Island County Supervisor of Assessments. Logan County Supervisor of Assessments agreed, saying "Bob's ethical standards and commitment to excellence are evident in his work."


McLean County officials joined those statewide praising Kahman. "He led his department in developing and displaying an accurate informational systemic approach which became exemplary, not only for our County, but throughout the State of Illinois," said McLean County Board Chairman John D. McIntyre. "Bob was also very involved with the GIS, E911, and Devnet Property Tax Software System conversion that McLean County put into place during the early 2000s. Through communication, collaboration and the cooperation of everyone involved, McLean County was finally able to issue a single bill in 2005 to avoid the costly and antiquated method of accelerated billing," said McLean County Treasurer Rebecca McNeil.

Kahman has been McLean County Supervisor of Assessments since 1998, having previously served as Chief Deputy for the Deerfield Township Assessor (Lake County), Assistant Chief Deputy for the Addison Township Assessor (DuPage County), and Chief Deputy for Libertyville Township Assessor. He holds a bachelor's degree from St. Norbert College, De Pere, Wisconsin. He has been awarded the Illinois Property Tax Assessment institute's designation of Certified Illinois Assessing Officer Master (CIAO-M) and the International Association of Assessing Officers designation of Assessment Administration Specialist (AAS). Additionally, Bob has served for many years as an instructor with the Illinois Property Assessment Institute, teaching both basic courses to prospective assessors and advanced topics to current ones.

Kahman is actively involved in his community church by volunteering to help with dinners and taking part in men's fellowship and Bible study. Bob volunteers with the McLean County Humane Society and helps with everything from walking dogs, building kennels, and occasionally fostering. Kahman and his wife Jane have five daughters: Roseanne, Elizabeth, Mary, Emma, and Kelly.

Legislative Committee Update



Mark Armstrong, Legislative Chair Kane County Assessor

The Legislative Committee of the Illinois Association of County Officials is beginning work on the 2022 legislative year, which will (again) be an unusual session. The most unusual feature of 2022 is not COVID-related precautions, but a very front-loaded schedule.

Due to the change in the primary election date from March to June, the legislative session will begin earlier, end earlier, and run more quickly than in years past: both chambers are scheduled to convene on January 4 and adjourn on April 8, the latter being 53 days earlier than the typical May 31 deadline.

Accordingly, the IACO Legislative Committee is meeting earlier than normal (convening before Christmas) to begin its work for the year. The Committee is made up of the legislative chairs of each of our affiliate organizations:

- Assessment Officers
- Auditors
- Clerks and Recorders
- Coroners and Medical Examiners
- County Board Members
- Court Clerks
- Regional Superintendents of Schools
- Treasurers
- Veterans Assistance Commissioners

The Committee is assisted in its work by each affiliate president as well as each affiliate's contract lobbyist. The Committee meets by video conference before and during each year's legislative session to mutually support the legislative goals of affiliate organizations. The Committee also offers a legislative session at the IACO Spring Conference; the 2021 Legislative Breakfast featured Representatives and Senators from both caucuses answering questions from the County Officials in attendance.

IACO affiliate members who would like more information on the legislative agendas of their affiliate organizations should contact their affiliate's legislative Chair. For more information about the IACO Legislative Committee, contact IACO Legislative Chairman Mark Armstrong.

The IACO Legislative Committee held their most recent meeting via Zoom on December 21, 2021. The meeting was led by the Legislative Chair, Mark Armstrong and attended by Bobbi Rairden (IACO President) as well as representatives from the following IACO affiliate organizations: Assessment Officers, Clerks and Recorders, County Board Members, Court Clerks, and Treasurers.

Each affiliate organization gave a report on their legislative agendas for 2022. The next Legislative Committee Meeting will be Monday, January 31, 2022 via Zoom.
